## Notice under Section 708A(5)(e) Corporations Act

On 11 July 2012, Optiscan Imaging Limited ("the Company") issued 694,444 fully paid ordinary shares in accordance with the terms of its Convertible Security Agreement with Bergen Global Opportunity Fund, LP, which was announced to the market on 29 March 2012.
